INTRODUCTION

The purpose of this document – expansion of the opportunities for the use of SWIFT system for settlements in Russian currency.

SWIFT-RUR Recommendations Guide is prepared by the Russian National SWIFT Association. They fully meet SWIFT standards described in the SWIFT User Handbook, as well as meet the requirements of the Russian legislation for settlements in national currency of the Russian Federation through the Bank of Russia Payment System (BRPS).

To adjust international and Russian standard requirements, SWIFT-RUR Recommendations contains additional rules of SWIFT messages creation for settlements in Russian currency developed by the Russian Payments and Settlements Market Practice Group at the Russian National SWIFT Association, which provide:

- usage of unified technology for automation of processing of SWIFT messages in Russian currency and in foreign currencies,*
- straight-through processing of electronic payment documents in Russian currency both in credit organizations and in the Bank of Russia Payment System (BRPS),*
- decreasing of discrepancies in the practice of various banks at transmission of electronic payment documents in Russian currency,*
- close approach to international standards of execution of banking operations.*

Use of the SWIFT-RUR Guidelines should be regulated by the Account Service Agreement between financial institution–account owner and account servicing financial institution.

SWIFT-RUR Guidelines should be used in combination with the SWIFT User Handbook, which translation into Russian language was also performed by the Russian National SWIFT Association.

The document matches to November 2014 MT Standards Release.

Russian practice related content pointed by blue italics letters in comparison with SWIFT UHB related content except the Transliteration Table and Message Type Format Specifications Tables.

In accordance with the decision of the Russian Payments Market Practice Group (Russian PMPG) of the Russian National SWIFT Association (ROSSWIFT) of August 5, 2014 this edition of the Recommendations SWIFT-RUR is intended for SWIFT user preliminary analysis and clarification before its planning approval by ROSSWIFT Steering Committee in November 2014.

BASIC CHANGES

This Guidelines incorporates the following changes to its previous 2014.2 edition from 18.02.2014:

- 1. Added the Chapter with MT 942 description;*
- 2. New Addendum with transliteration table for telex;*
- 3. Some editorial changes were made to improve the usability and comprehension of the document.*

PART 1. GENERALITIES

1.1 MT DESCRIPTION

All financial messages exchanged via SWIFT network must accord the rules of formatting of relevant types of messages described in SWIFT User Handbook Standards MT volumes.

Message Formats Descriptions are presented in this Guide under the same structure and the same conventional symbols like those used in the volumes of the Standards of the SWIFT User Handbook set.

SWIFT-RUR Guide Statements related to specific requirements for Russian currency payments and settlements enforced by Russian legislation exposed by blue italics, e.g. this paragraph.

1.1.1 Message Type Scope

The scope specifies the sender and receiver of the message and provides an explanation on how the message is used. In some messages, an example of the message flow is also provided.

1.1.2 Message Type Format Specifications

The format specifications are the rules for the layout of the message type. This information is provided in table form as shown below:

The arrows (----> and ----|) indicate that the second sequence may be repeated

MT nnn (Message Type name) provides the message type number and name.

The table headings have the following meanings:

- **Status** indicates if the field is:

M – Mandatory, **O** - Optional

The status **M** for fields in optional (sub) sequences means that the field must be present if the (sub)sequence is present, and is otherwise not allowed.

- **Tag** is the field identification.
- **Field Name** is the detailed name of the field tag, for this message type.
- **Format/Options** provides permitted field length and characteristics.
- **No.** identifies the number of the field in the Field Specifications for the message type. It is also called Index.

Only fields and field tag options, which are shown in the message format, may be used in that message type.

1.1.3 MT Network Validated Rules

Network validated rules are validated on the network, that is, they are identified with an error code. Rules specified in this section affect more than one field in the message, placing a 'condition' on one of the fields specified. They are identified as Cn, or conditional rules. For example, in the MT 202, a rule states that if field 56a (Intermediary) is present, field 57a (Account With Institution) must also be present (Error Code C81).

1.1.4 MT Usage Rules

Usage rules are not validated on the network, that is, no error code is defined for them, but are nevertheless mandatory for the correct usage of the message. Rules specified in this section affect more than one field in the message, or more than one SWIFT message.

1.1.5 MT Guidelines

Guidelines are not validated on the network and are not mandatory for the correct usage of the message. They concern good practices. Guidelines specified in this section affect more than one field in the message, or more than one SWIFT message.

1.1.6 MT Field Specifications

The rules for the use of each field in the message are specified in this section. Each field is identified by its index number (as shown in the No. column of the MT format specifications), field tag and detailed field name, followed by a description of the field. The description may contain some, or all, of the following:

FORMAT specifies field formats which are allowed in the field.

PRESENCE indicates if the field is mandatory, optional, or conditional in its sequence.

DEFINITION specifies the definition of the field in this sequence of the message type.

CODES lists all codes available for use in the field. If there is more than one subfield for which codes are defined, each separate code list will be identified with a CODES heading. When a list of codes is validated by the network, the error code will be specified.

NETWORK VALIDATED RULES specifies rules that are validated on the network, that is, rules for which an error code is defined. Generally, rules specified in this section affect only the field in which they appear. In some cases, rules which are validated at the message level, that is, rules which affect more than one field are repeated in this section. This is the case when the rule does not affect the presence of the field, but information within several fields, for example, a currency which must be the same for more than one field in the message.

USAGE RULES specify rules that are not validated on the network, that is, rules for which no error code is defined, but are nevertheless mandatory for the correct usage of the field. Rules specified in this section affect only the field in which they appear.

EXAMPLES provide one or more examples of the field as it will be formatted/used.

1.2 IDENTIFICATION CODES

For Russian currency SWIFT messages equally with international identification codes are used russian codes: Bank Identification Code (BIK) (in Russian – “БИК”), Identification Number of the Tax Payer (INN), Foreign Corporate Code (KIO) and The Reason of Tax Registration Code (KPP).

1.2.1 Business Identifier Codes (BICs)

ISO 9362 Business Identifier Codes (BICs) are used in certain fields of financial messages to identify a party in the transactions.

The Business Identifier Code (BIC) consists of eight or eleven characters comprised the following components:

Institution Code code	4!a
Country code	2!a
Location code	2!c
Brach code	[3!c]

Business Identifier Codes (BICs) format:

4!a2!a2!c[3!c]

1.2.2 Bank Identification Code (BIK) (in Russian – “БИК”)

Bank Identification Code (BIK), in Russian – “БИК”, is a unique code assigned to each participant of The Bank of Russia Payment System.

Bank of Russia assigns BIK code to the financial institution.

Format and content of nine-digit code, which identifies participants of Local Clearing system of the Central Bank of the Russian Federation (the Bank of Russia), is specified in the Regulations of the Central Bank of the Russian Federation of May 6, 2003 No. 225-P "On the Directory of the Bank Identification Codes (BIK) of the participants of Local Clearing system of the Central Bank of the Russian Federation (the Bank of Russia)".

Bank Identification Code (BIK) format:

RU9!n

where RU – Code word according to SWIFT Standards MT used for the Bank of Russia Payment system identification.

1.2.3 Identification Number of the Tax Payer (INN)

INN code, in Russian – “ИИИ”, - Identification Number of the Tax Payer – is a unique identifier of the individual, self-employed individual or legal entity assigned them on their registration in the Tax Authorities of the RF based on Tax Code of Russian Federation.

In accordance with the regulations of the Bank of Russia, INN code, if assigned, must be indicated for the payment originator (Ordering Customer or Ordering Institution) and for the final Beneficiary of the funds (Beneficiary or Beneficiary Institution), in the fields 50a and 59a of MT 101 and MT 103, or in the fields 52a and 58a of MT 202 (see descriptions of these MT for details).

Identification Number of the Tax Payer (INN) is a numeric string which is 10 digits for legal entities or 12 digits for individuals.

Identification Number of the Tax Payer (INN) format:

3!a12n must be used in one of the following options

3!a10!n – for legal entities

or

3!a12!n – for individuals,

where 3!a – code word INN.

1.2.4 Foreign Corporate Code (KIO)

Foreign Corporate Code (KIO), in Russian – “КИО” is a unique identifier of a foreign corporate (inclusive banks or other financial institutions) which is registered in the Tax Authorities of the RF. KIO, if KIO assigned and INN is not assigned, must be indicated in the payment instructions to the payment originator (Ordering Customer or Ordering Institution) in the field 50a of MT 101, 103 and 910, in the field 52a of MT 103, 202, 900 and 910, in the field 58a of MT 202 and in the field 59 of MT 101 and 103 (see descriptions of these MT for details).

Foreign Corporate Code (KIO) is a numeric string which is 5 digits.

Foreign Corporate Code (KIO) format:

3!a5!n

where 3!a – code word INN.

As KIO, if assigned, is indicated in payment instructions in case of no INN assigned to this corporate exists, it should be indicated in the subfield where normally INN is placed, which format is 3!a12n (see item 1.2.3)

1.2.5 The Reason of Tax Registration Code (KPP)

The Reason of Tax Registration Code (KPP), in Russian – "КПП", is assigned to the tax-payer (the fee payer) – corporate in addition to the Identification Number of the Tax Payer (INN), as a result of their registration in the Tax Authorities of the RF. In accordance with the requirements of the Bank of Russia KPP, if assigned, must be indicated in the payment instructions to transfer the taxes, fees and other mandatory payments to the budget of the Russian Federation. KPP code may be thus used in the fields 50a and 59a of MT 101 and MT 103 (see descriptions of these MT for details).

The Reason of Tax Registration Code (KPP) is a numeric string which is 9 digits.

The Reason of Tax Registration Code (KPP) format:

3!a9n must be used in one of the following options

3!a9!n – for legal entities

or

3!a1!n – for individuals

,where

3!a – code word KPP,

1!n – always "0".

1.3 CHARACTER SET AND TRANSLITERATION

The following Character Set is allowed in the fields of the message text of MT covered by this Guide

The characters Cr and Lf must never be used as single characters and must only be used together in the sequence CrLf, that is, LfCr is not allowed.

The character sequence CrLf is only allowed in multi-line fields and is used to indicate the end of one line of text and the start of the next line of text.

As this Character Set does not contain Cyrillic alphabetic characters, exchange of financial messages in the currency of the Russian Federation via SWIFT is performed using conversion from Cyrillic letters to Roman

letters. Conversion based on the unified Table of transliteration and is in accordance with the Rules described in this Guide.

The Table and Rules of transliteration described in this section provide successful conversion from Cyrillic letters to Roman letters. Transliteration should be applied to the messages generated on the Sender's side which contain Cyrillic letters and are to be processed on the Receiver's side in Russian language.

Transliteration should be reversible, i.e., information subject to two sequential transliterations (on the Sender's side and then on the Receiver's side) should be identical to itself in sending and in receiving provided the most adequacy of information transmitted.

1.3.1 Sign of Transliteration

To indicate that the message must be transliterated on the Receiver's side, the message Sender put the transliteration sign into the first position of the field 20 "Sender's Reference/Operation's reference".

SWIFT-RUR Guide use character plus "+" (hexadecimal code 2B) as the sign of transliteration. This sign designates that transliteration should be applied to the message in accordance with the rules and the Table of Transliteration described in SWIFT-RUR.

In case of SWIFT-RUR transliteration is applied, then:

- transliteration sign is an integral part of message reference;
- in case of the Sender's Reference is generated automatically by application software, it is necessary to bear in mind that the size of the field 20 "Sender's reference/Operation's reference" in the SWIFT messages subject to transliteration, must not exceed sixteen characters with consideration for Plus "+" sign in the first position;
- in case of conversion from Roman alphabet to Cyrillic alphabet, plus "+" sign must not be deleted by the transliteration software from the contents of the field 20.

1.3.2 Rules of Transliteration

Each letters of Russian alphabet is transliterated by corresponding single letters of Roman alphabet.

To expand the character set of Roman alphabet and to avoid the size of field content increase, UPPER case letters and lowercases letters are used in accordance with the Table of transliteration.

Service symbols are transliterated without conversion into relevant service symbols.

Field and sub-fields of only text block of the message are subject to transliteration.

Transliteration should not apply to:

- servicing components of the message (headers, trailers, field tags, field options, and colons, which limit the field tags, symbols <Lines feed>, <Carriage return>, apostrophe, etc.);

- content of the reference field (field 20) and content of the Related Reference field (field 21);
- fields, which contain digits, code words or other codes, in accordance with the SWIFT standards;
- fields with option A, which identify participants of transfer chain;
- roman letters contained in the field subject to transliteration;
- code words enclosed between two slashes;
- all fields and subfields in the message MT940 "Customer Statement Message", except subfield 9 "Supplementary Details" of the field 61 "Statement Line" and field 86 "Information to Account Owner";
- all fields and subfields of the message MT950 "Statement Message", except subfield 9 "Supplementary Details" and field 61 "Statement Line".

If original content of the field or subfield in Russian language contain Latin letters they must be putted between two apostrophes by transliteration process. As a result, transliterated text contains a trigger "RUS/ENG-ENG/RUS" (apostrophe) before Roman letters and after them.

Comments:

1. Apostrophe encountered in the original text must be transliterated by lowercase letter j. Apostrophe encountered in the transliterated text as the trigger “*RUS/ENG–ENG/RUS*”.

2. Braces encountered in the original text must be transliterated by round brackets, which must not be converted by reverse transliteration. Exception is braces in Code of Currency Transaction string in the Remittance Information field (see The Exclusion from the Rules of Transliteration).

THE EXCLUSION FROM THE RULES OF TRANSLITERATION.

Applied to the field 70 in SWIFT MT 101 and MT 103 and to the field 72 with /NZP/ code word in SWIFT MT 202 according to the The Bank of Russia Directive No.138-I of June 04, 2012.

Based on clarifications of the Bank of Russia, symbols of braces, which limit coded information of the currency transaction in the field "Details of payment" of the Payment Order, must be replaced by round brackets via the process of transliteration from Cyrillic alphabet to Roman alphabet in relevant field of SWIFT message. In case of reverse transliteration, round brackets are replaced by symbols of braces.

The base to apply The Exclusion from the Rules of Transliteration is the combination of characters arranged as follows, appear from the first position of appropriate field of SWIFT message: apostrophe - round bracket - VO < Code> - round bracket – apostrophe.

EXAMPLES OF TRANSLITERATION:

1. Original text on Sender's side (before transliteration) - (66 positions):

Text of SWIFT message (after transliteration according to SWIFT-RUR Guide) - (68 positions):

€TOT TEKST DOLJEN KORREKTNO PEREDATXSa PO SETI 'SWIFT' V DRUGOi BANK

Text on Receiver's side (after reverse transliteration) - (66 positions):

ЭТОТ ТЕКСТ ДОЛЖЕН КОРРЕКТНО ПЕРЕДАТЬСЯ ПО СЕТИ SWIFT В ДРУГОЙ БАНК

2. Original text on Sender's side (before transliteration) - (79 positions):

Оплата за товар по счёту №123 от 12.01.2010, в т. ч. НДС (20%) 1800 руб.00 коп.

(Translation to English is following: "Payment for goods under invoice #123 dd.12.01.2010, incl. VAT (20%) 1800 rub. 00 kop.")

Text of SWIFT message (after transliteration according to SWIFT-RUR Guide) - (79 position):

OPLATA ZA TOVAR PO ScoTU n123 OT 12.01.2010, V T. c. NDS (20p) 1800 RUB.00 KOP.

Text on Receiver's side (after reverse transliteration) - (79 positions):

ОПЛАТА ЗА ТОВАР ПО СЧЁТУ №123 ОТ 12.01.2010, В Т.Ч. НДС (20%) 1800 РУБ. 00 КОП.

3. Original text on Sender's side (before transliteration) - (28 positions):

{VO10040} Оплата по договору

(Translation to English is following: “={VO10040} Payment under contract”)

Text of SWIFT message (after transliteration according to SWIFT-RUR Guide) - (30 positions):

'(VO10040)' OPLATA PO DOGOVORU

Text on Receiver's side (after reverse transliteration) - (28 positions):

{VO10040} Оплата по договору

4. Original text on Sender's side (before transliteration) - (68 positions):

Оплата компании DON'T WORRY по договору ABC1111 по счёту 2222DEF3333

Text of SWIFT message (after transliteration according to SWIFT-RUR Guide) - (75 positions):

OPLATA KOMPANii 'DON'j'T WORRY 'PO DOGOVORU 'ABC1111 'PO SCoTU 2222'DEF3333

Text on Receiver's side (after reverse transliteration) - (68 positions):

ОПЛАТА КОМПАНИИ DON'T WORRY ПО ДОГОВОРУ ABC1111 ПО СЧЁТУ 2222DEF3333

1.3.3 Transliteration Table Version Descriptor

SWIFT-RUR Guide introduce a concept of Transliteration Table Version Descriptor, which defines the version of SWIFT-RUR Transliteration Table used by the Sender.

This sign is optional for all types of messages. If it is used then it is indicated in the block 3 “User Header Block” in the field 113. It has format 4!x. If the field is absent then SWIFT-RUR Transliteration Table that is contained in the active SWIFT-RUR Document is used (the Document activation date is defined in Introduction section).

Note: In this document nhe Transliteration Table remains unchanged from SWIFT-RUR Version 6. So, if this Table is using then during the document activity period field 113 could be absent or used with value: RUR6.

1.4 FIELD FORMATTING RULES

The following base rules must be conformed for all fields:

Field length and type of symbols are defined in descriptions of specific types of messages.

Unless otherwise specified, all specified subfields should be included in the field:

- in specified sequence
- without separating symbols (except “/” and “//”, where required).

Square brackets, which include the format of any subfield, indicate that it is optional in this field. For example, if field format -16x[/4x], then it must contain without fail up to 16 symbols of X Character Set, while the next 4 symbols of X set preceded by slash “/” are optional and may be thus missed.

Field format may represent two or more lines:

In this case they must be separated with “CrLf”.

1.4.1 Dates

The dates are defined by four, six or eight digits in one of the following ISO formats: MMDD, YYMMDD or YYYYMMDD, where Y - year, M - month, D - day. For example, 19960527 = May 27, 1996.

In six-digit format, the dates are interpreted as follows:

If YY > 79, then YYMMDD = 19 YYMMDD,

Otherwise YYMMDD = 20 YYMMDD.

Limitation of the dates by a range of from 1980 to 2060 is applied to the fields 30 and/or 32A of the message MT910 and to the messages of 1 and 2 categories, except MT 192, 292, 195, 295, 196 and 296.

1.4.2 Amounts

FORMAT:

nnnn, nn

Fields of amounts and numerical fields similar to them (interest rate, conversion rate) are always used in accordance with the following rules:

- Integer part should comprise at least one digit.
- Maximum length comprises comma between integer part and fractional part.
- Fractional part may be absent, but the comma between integer part and fractional part should be always available.
- Presence of spaces, as well as other symbols other than comma is not permissible.
- Such fields should not be blank or begin with zero, with the exception of zero indicated in integer part, with subsequent comma.

1.4.3 Currency code

A currency code normally consists of a two-letter ISO country code followed by a third letter denoting the particular currency or type of funds. In particular, for Russian currency it looks like RUB.

1.4.4 Party Identifier

Parties may be represented in several ways:

- Code BIC (see section 1.2.1);
- Code BIK (see section 1.2.2);
- Name and account number;
- Name, or name and location or full name, patronymic and surname (unless otherwise provided for by law or national habit) together with the necessary additional details in accordance with requirements of The Bank of Russia Regulation No.383-P of June 19, 2012, "On the rules of funds transfer execution". In addition the party may be identified by Identification Number of the Tax Payer (INN), Foreign Corporate Code (KIO) and The Reason of Tax Registration Code (KPP).

The rules for use of different ways of party identification described in 1.4.6 "Field Option" section as well as in the descriptions of fields 50a, 52a, 58 and 59a of SWIFT messages.

1.4.5 Optional line Party Identifier

Party Identifier line is used when further definition of the party is required (for example, to identify account number to apply funds).

Account number in "Party Identifier" line of fields 59a or 58a belongs to the party specified in this field and is serviced by financial organization in the field 57a, or, if not presented, - by Receiver of the message.

Account number in "Party Identifier" line of field 56a belongs to the party specified in this field and is serviced by Receiver of the message.

Account number indicated in "Party Identifier" line of field 57a belongs to the party specified in this field and is serviced by financial organization indicated in field 56a, or, if it is absent, - by the message Receiver.

Party Identifier in field 53a may be presented in the following cases only:

If the message Receiver services for the Sender more than one account in the currency of transaction, then the "Party Identifier" line defines, what of these accounts should be debited for funds transfer. In this case, if bilateral agreement on default use of one of available accounts for funds transfer exists between the Sender and the Receiver, field 53a may be included in the payment instructions only in exceptional cases, when account other than default account should be used.

If both of the message Sender and the message Receiver service accounts for each other in the currency of transaction, then the "Party Identifier" line defines, what account should be used for funds transfer - the Sender's account serviced by the Receiver or the Receiver's account serviced by the Sender. In this case action on the account (debit or credit) is defined in subfield "Party Identifier" by codes /D or /C, or account number, respectively, or both of them. In this case, if bilateral agreement on default use of one of mutual accounts in making payments is made between the Sender and the Receiver, SWIFT message may contain field 53a in exceptional cases only, when account other than default account should be used.

In both cases above, the field 53a is used only with option B, and contains only the "Party Identifier" line.

In all other cases, the procedure of use of the field 53a should be specified particularly in bilateral agreements.

1.4.6 Field Options

In all cases, it is recommended to stipulate particularly in bilateral agreements what field options may be used in SWIFT messages in transactions where SWIFT-RUR Guide is applied.

PART 2. FORMATS OF FINANCIAL MESSAGES

CATEGORY 1. CUSTOMER PAYMENTS

The messages in Category 1 deal with payments, or information about payments, in which the ordering party or the beneficiary, or both, are not financial institutions.

2.1 MT 101 REQUEST FOR TRANSFER

Note: To use the message of this type, registration in the Message User Group (MUG) is required.

Use of the message MT 101 requires preliminary arrangements and establishment of contractual relations between all parties involved in the exchange of MT 101 and execution of payment instructions contained in this message.

SWIFT recommendations related to the exchange of MT 101 are presented in the sections "Procedure of MT 101 use" and "Rules of work with MT 101 and control list" of MT 101 message description in SWIFT User Handbook.

2.1.1 Scope

This message is sent by financial organization by order of the account owner, which is non-financial organization, i.e., by order of the Payer/ Instructing Party, and then is received by the financial organization - Receiver and is executed by the financial organization - Receiver or the Account Servicing Institution.

It is used to forward payment instructions to transfer funds from the ordering customer's account(s) serviced at the receiving financial institution or at the account servicing institution, or from an account(s) owned by the Ordering Customer which the instructing customer has explicit authority to debit, for example, a subsidiary account.

The MT 101 can be used to order the movement of funds:

- between ordering customer accounts,
- in favour of a third party, either domestically or internationally.

Notes:

1) Message MT 101 is used only for execution of debit operations of the account owner, i.e., it cannot contain collection orders or direct debit orders. In case of such demand in practice, it is necessary to apply to ROSSWIFT.

2.1.2 Format Specifications

Message MT 101 consists of two sequences:

Sequence A –General Information is a single occurrence mandatory sequence and contains information to be applied to all individual transactions detailed in sequence B.

Sequence B – Transaction Details is a repetitive sequence; each occurrence provides details of one individual transaction. Fields which appear in both sequences are mutually exclusive.

ATTENTION!

The field 71A with code words SHA and BEN, fields 33B, 36 may be presented only when funds transfer is not to be executed through the Bank of Russia Payment System, because their content can't be presented in the Bank of Russia payment documents (see Usage Rules for these fields).

Besides, the field 23E may be presented only when funds transfer is not to be executed through the Bank of Russia Payment System, except it is presented with code words OTHR/RPP, OTHR/UIP, OTHR/NZP and OTHR/N1 (see Usage Rules for the field 23E).

Field 51 is not used, as it is not exchanged via SWIFT FIN service.

2.1.3 MT 101 Network Validated Rules for SWIFT-RUR.

Network Validated Rules are presented in the relevant section of the SWIFT User Handbook: volume "Category I "Customer Payments and Cheques", including the following rules:

Consequently, field 50a (option F or H), must be present in either sequence A or in each occurrence of sequence B, but must never be present in both sequences, nor be absent from both sequences (Error code(s): D61).

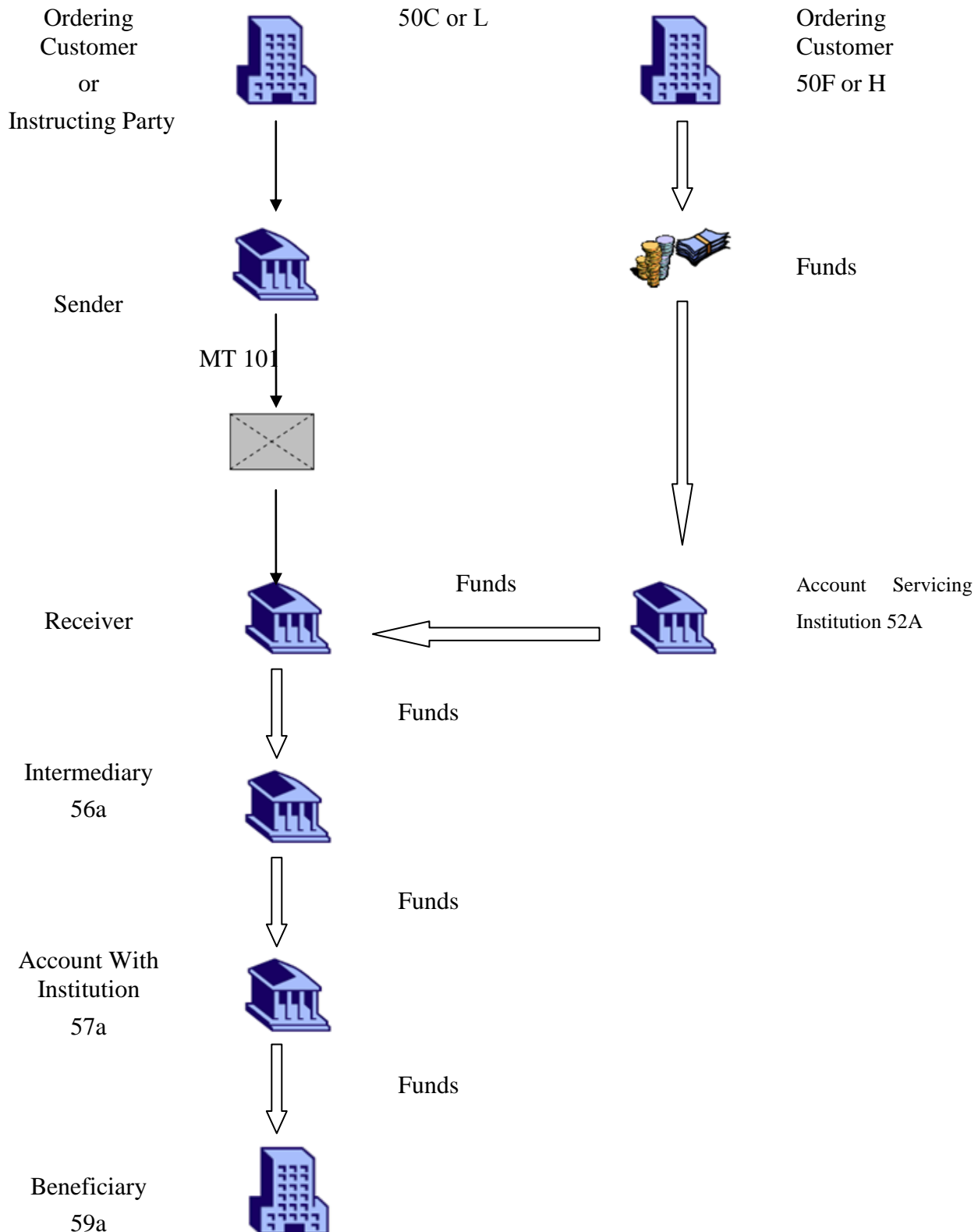

Numbers 1 and 2 may be repeated, if more than one line is required, to present full details, for example to enter Name of the Ordering Customer.

Number 1 "Name of the Ordering Customer" must be presented, but codes 1 "Tax Codes", codes 2, 3, 6, 7, 8, may be presented in addition.

Number 1 “Tax Codes “ if presented, must appear on the first line of subfield 2 (Name and Address) and then Number 1 “Name of the Ordering Customer “ appear on the next line(s) of subfield 2 (Name and Address).

Number 2 must not be used without number 3.

Numbers 4 and 5 must not be used.

The use of number 8 is only allowed to continue information on the Identifier of the ordering customer provided in subfield 1 (Party Identifier) used with the (Code)(Country Code)(Identifier) format.

USAGE RULES

1. Both the account number of the ordering customer at the Receiver or at the account servicing institution and the name must be present.

2. Account number of the ordering customer must be indicated in subfield "Account". IBAN is allowed.

If Account Servicing Institution execute a payment without opening account then it is permitted usage of F option with subfield Party Identifier (Code) used with the (Country Code)(Identifier) format. In this case it is mandatory to define information with codes CCPT or DRLC.

3. According to RF legislation and the Bank of Russia regulations SWIFT message must contain Full set of Ordering Customer's details. Either option H (see section 1.4.6 “Field options”) or option F may be used.

In option F Number Code 1 “Tax Codes “ if presented, must appear on the first line of subfield (Name and Address) and then Number Code 1 “Name of the Ordering Customer “ appears on the next line(s) of subfield (Name and Address).

In case of the Ordering Customer is a person, the following details must be presented with option F:

- Identification Number of the Tax Payer (INN) if assigned following the number code 1 “Tax Codes “ on the first line of the subfield 2 (Name and Address),and

- the surname, name(s) and patronymic name (unless otherwise provided for by law or national habit) following the number code 1 “Name of the Ordering Customer “.

In case of the Ordering Customer - a person has no Identification Number of the Tax Payer (INN) the following details must be presented completely:

-- the surname, name(s) and patronymic name (unless otherwise provided for by law or national habit) following the number code 1 "Name of the Ordering Customer "

and

- place of residence or address following number codes 2 "Address Line" and 3 "Country and Town".

Identifier Code must be a financial institution BIC. This error code applies to all types of BICs referenced in a FIN message including SWIFT BICs, non-SWIFT BICs, Masters, Synonyms, Live destinations and Test & Training destinations (Error code(s): C05).

USAGE RULES

Option D should be used when bank name and location is required for example, in connection with mandatory reporting.

This information should be enclosed in braces and placed in the beginning of the field "Details of payment" formatted as follows: {VO< Code>}. Spaces inside the braces are inadmissible.

However braces cannot present in the SWIFT message text. Therefore the following Exclusion from the Rules of Transliteration is applied.

THE EXCLUSION FROM THE RULES OF TRANSLITERATION

Applied to the field 70 in SWIFT MT 101 and MT 103 and to the field 72 with /NZP/ code word in SWIFT MT 202 according to The Bank of Russia Directive No.138-I of June 04, 2012.

Based on clarifications of the Bank of Russia, symbols of braces, which limit coded information of the currency transaction in the field "Details of payment" of the Payment Order, must be replaced by round brackets via the process of transliteration from Cyrillic alphabet to Roman alphabet in relevant field of SWIFT message. In case of reverse transliteration, round brackets are replaced by symbols of braces.

The base to apply The Exclusion from the Rules of Transliteration is the combination of characters arranged as follows, appear from the first position of appropriate field of SWIFT message: apostrophe - round bracket - VO < Code> - round bracket –apostrophe.

This field specifies code(s) for the statutory and/or regulatory information required by the authorities in the country of the Receiver or the Sender/originating customer.

According to SWIFT-RUR Guide, codes for state tax or customs authorities must present in this field when MT 101 includes payment instructions to transfer the tax and other obligatory payments. These codes represent the status of the ordering customer and other details according to the Ministry of the Russian Federation on Taxes and Fees, Ministry of Finance of the Russian Federation and State Customs Committee of the Russian Federation requirements.

Two kinds of obligatory payments can be presented in MT 101:

- transfer tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation

and

- transfer of customs duties or other payments related to external economic activity.

Information following the same code in this field differs depending of the kind of obligatory payment containing in MT 101.

To transfer of tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation this field contains the following information structured by identifiers in slashes "/".

IDENTIFIERS

In formatting of SWIFT message to transfer of tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation this field should being split to subfields. Each subfield has an identifier and strictly corresponds with the field of the payment document of the Bank of Russia.

Note: *in case of absence of particular values user should act in accordance with Ministry of Finance of RF and the Bank of Russia regulations to use number of zeroes needed.*

Each subfield contains code sequence. The following subfield identifiers and code sequences are to be used:

/N4/ - Corresponds to the field 104 of the payment document of the Bank of Russia.

Codes SHA and BEN cannot be present when funds transfer is to be executed through the Bank of Russia Payment System, as this information cannot be present in the payment document of the Bank of Russia. Using codes SHA and BEN in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT 101 understands that in this stage of funds transfer the content of this field will be lost and it's function will not be executed completely.

USAGE RULES

Using field 36 in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT 101 understands that in this stage of funds transfer the content of this field will be lost and it's function will not be executed completely.

2.2 MT 103 SINGLE CUSTOMER CREDIT TRANSFER

SWIFT-RUR presents the minimum necessary MT 103 fields set, which allows forward all necessary information to create the Bank of Russia payment document – Payment Order - on the Receiver's side.

SWIFT-RUR Guide covers the exchange of SWIFT MT 103 only in its basic format.

2.2.1 Scope

This message type is sent by or on behalf of the financial institution of the ordering customer, directly or through (a) correspondent(s), to the financial institution of the beneficiary customer.

It is used to convey a funds transfer instruction in which the ordering customer or the beneficiary customer, or both, are non-financial institutions from the perspective of the Sender.

This message may only be used for clean payment instructions. It must not be used to advise the remitting bank of a payment for a clean, for example, cheque, collection, nor to provide the cover for a transaction whose completion was advised separately, for example, via an MT 400.

Cover method of Transfer of funds is not in practice for Russian rubles and the fields 53A, 53D, 54A and 55is not allowed in MT 103 because their content can't be present in the Bank of Russia payment documents (see Usage Rules for these fields).

The fields 23E, 71A with code words SHA and BEN, 33B, 36, 71F and 71G may be present only when funds transfer is not to be executed through the Bank of Russia Payment System, because their content can't be present in the Bank of Russia payment documents.

Using above mentioned fields in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT 103 understands that in this stage of funds transfer the content of these fields will be lost and it's function will not be executed completely.

Usage of field 71F must be bilateral agreed between Sender and Receiver.

Both fields 26T "Transaction Type Code" and 77B "Regulatory Reporting" must be present in MT 103 for tax or other obligatory payments filled strictly in accordance with field description presented in SWIFT-RUR Guide. Tax Payer status code is defined with preceding S character in accordance with Ministry of Finance regulations. If the code is consist of one digit then position before it fills with zero.

Field 72 may be available only in structured form, i.e., contains encoded information only.

In MT 103 which contains Payment Requirement – a payment document of the Bank of Russia – (kind of transaction – 02), cannot be present content of the following fields of Payment Requirement: "Payment Conditions", Term to Accept", "The Date of Dispatch (Delivery) to the Payer of document set under agreement" and "The Final Date to Accept".

2.2.5 MT103 Guidelines

If the Sender and the Receiver wish to use their direct account relationship in the currency of the transfer, then the MT 103 message will contain the cover for the customer transfer as well as the payment details.

Where more than two financial institutions are involved in the payment chain, and if the MT 103 is sent from one financial institution to the next financial institution in this chain, then the payment method is called 'serial'.

If the Receiver does not service an account for the beneficiary customer, and no account servicing institution is indicated nor any alternative instructions given, then the Receiver will act upon the customer credit transfer instruction in an appropriate manner of its choice.

In order to allow better reconciliation by the beneficiary customer, the MT 103 supports full charges transparency and structured remittance information.

2.2.6 103 Field Specifications

1. Field 20: Sender's reference

FORMAT

16x

PRESENCE

Mandatory

DEFINITION

This field specifies the reference assigned by the Sender to unambiguously identify the message. The field is not used to indicate the Payment Order number.

NETWORK VALIDATED RULES

This field should not begin with slash "/", end with slash or contain double slash "/"

USAGE RULES

This reference must be quoted in any related confirmation or statement, for example, MT 900, MT 910 and/or MT 940, 950.

The reference must be unique for each message (or chain of messages) and is part of the message identification and transaction identification which is to be used in related queries, cancellations, etc.

The first position of this field must be used for transliteration sign placement (see item 1.3.1).

2. Field 23B: Bank Operation Code

Mandatory

DEFINITION

This field identifies the type of operation.

CODES

SWIFT-RUR Guide allows only one code CRED in this field – “This message contains a credit transfer where there is no SWIFT Service Level”

HOLD Beneficiary customer/claimant will call; pay upon identification.

CHQB Pay beneficiary customer only by cheque. The optional account number line in field 59 must not be used.

PHOB Please advise/contact beneficiary/claimant by phone.

TELB Please advise/contact beneficiary/claimant by the most efficient means of telecommunication.

PHON Please advise account with institution by phone.

TELE Please advise account with institution by the most efficient means of telecommunication.

PHOI Please advise the intermediary institution by phone.

TELI Please advise the intermediary institution by the most efficient means of telecommunication.

NETWORK VALIDATED RULES

Additional Information is only allowed when Instruction Code consists of one of the following codes: PHON, PHOB, PHOI, TELE, TELB, TELI, HOLD or REPA (Error code(s): D97).

If this field is repeated, the codes must appear in the following order (Error code(s): D98):

When this field is used more than once, the following combinations are not allowed (Error code(s): D67):

If this field is repeated, the same code word must not be present more than once (Error code(s): E46).

USAGE RULES

This field may be repeated to give several coded instructions to one or more parties.

The field 23E may be present only when funds transfer is not to be executed through the Bank of Russia Payment System, because their content can't be present in the Bank of Russia payment documents.

According to SWIFT-RUR Guide this field is used in payment instructions to transfer tax and other obligatory payments and contains the code represented the status of the ordering customer. This field

corresponds to the field 101 of the payment documents of the Bank of Russia. If the field 26T is present in the message, the field 77B must be present as well. Tax Payer status code is defined with preceding S character in accordance with Ministry of Finance regulations. If the code is consist of one digit then position before it fills with zero.

USAGE RULES

This information is intended for regulatory reporting to state and controlling units as well as for Beneficiary to clarify the nature of operation.

EXAMPLES

5. Field 32A: Value date/Currency/Amount of interbank payment

PRESENCE

Mandatory

DEFINITION

This field specifies the value date, the currency and the settlement amount. The settlement amount is the amount to be booked/reconciled at interbank level.

NETWORK VALIDATED RULES

Date must be a valid date expressed as YYMMDD (Error code(s): T50).

Currency must be a valid ISO 4217 currency code (Error code(s): T52).

The integer part of Amount must contain at least one digit. A decimal comma is mandatory and is included in the maximum length. The number of digits following the comma must not exceed the maximum number allowed for the specified currency (Error code(s): C03, T40, T43).

USAGE RULES

If field 33B is present in the message received, it has to be forwarded unchanged to the next party.

This field must be present when a currency conversion or an exchange has been performed on the Sender's side.

This field must be present if payment instructions includes directives about Sender (71G) or Receiver (71F) commissions.

As a consequence, if there are no Sender's or Receiver's charges and no currency conversion or exchange took place, field 32A equals 33B, if present.

This field must not be present in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT 103 understands that in this stage of funds transfer the content of these fields will be lost and it's function will not be executed completely.

This field specifies the exchange rate used to convert the instructed amount specified in field 33B.

USAGE RULES

This field must be present when a currency conversion or an exchange has been performed on the Sender's side.

This field must not be present in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT 103 understands that in this stage of funds transfer the content of these fields will be lost and it's function will not be executed completely.

Each code must appear at the beginning of the separate line.

Numbers must appear in ascending order

Numbers 1 and 2 may be repeated, if more than one line is required, to present full details, for example to enter Name of the Ordering Customer.

Number 1 "Name of the Ordering Customer " must be presented, but codes 1 "Tax Codes", codes 2, 3, 6, 7, 8, may be presented in addition.

Number 1 "Tax Codes " if presented, must appear on the first line of subfield 2 (Name and Address) and then Number 1 "Name of the Ordering Customer " appear on the next line(s) of subfield 2 (Name and Address).

Number 2 must not be used without number 3.

Numbers 4 and 5 must not be used.

The use of number 8 is only allowed to continue information on the Identifier of the ordering customer provided in subfield 1 (Party Identifier) used with the (Code)(Country Code)(Identifier) format.

USAGE RULES

1. Both the account number of the ordering customer at the Receiver or at the account servicing institution and the name must be present.

2. Account number of the ordering customer must be indicated in subfield "Account". IBAN is allowed.

If Account Servicing Institution execute a payment without opening account then it is permitted usage of F option with subfield Party Identifier (Code) used with the (Country Code)(Identifier) format. In this case it is mandatory to define information with codes CCPT or DRLC.

3. According to RF legislation and the Bank of Russia regulations SWIFT message must contain Full set of Ordering Customer's details. Either option K (see section 1.4.6 "Field options") or option F may be used.

In option F Number Code 1 "Tax Codes " if presented, must appear on the first line of subfield (Name and Address) and then Number Code 1 "Name of the Ordering Customer " appears on the next line(s) of subfield (Name and Address).

In case of the Ordering Customer is a person, the following details must be presented with option F:

- Identification Number of the Tax Payer (INN) if assigned following the number code 1 "Tax Codes " on the first line of the subfield 2 (Name and Address),and

- the surname, name(s) and patronymic name (unless otherwise provided for by law or national habit) following the number code 1 "Name of the Ordering Customer ".

In case of the Ordering Customer - a person has no Identification Number of the Tax Payer (INN) the following details must be presented completely:

-- the surname, name(s) and patronymic name (unless otherwise provided for by law or national habit) following the number code 1 "Name of the Ordering Customer "

and

- place of residence or address following number codes 2 "Address Line" and 3"Country and Town".

USAGE RULES

The information specified in this field is intended only for the beneficiary customer, that is, this information only needs to be conveyed by the Receiver.

Multiple references can be used, if separated with a double slash, '//'. Code must not be repeated between two references of the same kind.

Only if the size of the field 70 is insufficient to enter details of payment completely it is permissible to continue this information in the field 72 "Sender to Receiver Information" with the code word NZP.

Total size of payment details in the field 70 and in the field 72 with the code word NZP after transliteration must not exceed 210 characters.

ADDITIONAL USAGE RULES

According to The Bank of Russia Directive No.138-I of June 04, 2012, Currency Transaction Code must present in the field 70 "Remittance Information", and may be followed by Transaction Certificate Number.

Separating symbol VO precedes Currency Transaction Code. Separating symbol VO is printed by Roman capital letters.

This information should be enclosed in braces and placed in the beginning of the field "Details of payment" formatted as follows: {VO< Code>}. Spaces inside the braces are inadmissible.

However braces cannot present in the SWIFT message text. Therefore the following Exclusion from the Rules of Transliteration is applied.

THE EXCLUSION FROM THE RULES OF TRANSLITERATION

Applied to the field 70 in SWIFT MT 101 and MT 103 and to the field 72 with /NZP/ code word in SWIFT MT 202 according to The Bank of Russia Directive No.138-I of June 04, 2012.

Based on clarifications of the Bank of Russia, symbols of braces, which limit coded information of the currency transaction in the field "Details of payment" of the Payment Order, must be replaced by round brackets via the process of transliteration from Cyrillic alphabet to Roman alphabet in relevant field of SWIFT message. In case of reverse transliteration, round brackets are replaced by symbols of braces.

The base to apply The Exclusion from the Rules of Transliteration is the combination of characters arranged as follows, appear from the first position of appropriate field of SWIFT message: apostrophe - round bracket - VO < Code> - round bracket –apostrophe.

15. Field 71A: Details of Charges

FORMAT

DEFINITION

This field specifies which party will bear the applicable charges for the subsequent transfer of funds.

CODES

One of the following codes may be used:

OUR - All transaction charges for the subsequent credit transfer are to be borne by the ordering customer.

SHA - All transaction charges other than the charges of the financial institution servicing the ordering customer account are borne by the beneficiary customer.

BEN - All transaction charges, including the charges of the financial institution servicing the ordering customer's account, for the subsequent credit transfer(s) are to be borne by the beneficiary customer.

USAGE RULES

Codes SHA and BEN cannot be present when funds transfer is to be executed through the Bank of Russia Payment System, as this information cannot be present in the payment document of the Bank of Russia.

Using codes SHA and BEN in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT103 understands that in this stage of funds transfer the content of this field will be lost and it's function will not be executed completely.

This repetitive field specifies the currency and amount of the transaction charges deducted by the Sender and by previous banks in the transaction chain.

NETWORK VALIDATED RULES

Currency must be a valid ISO 4217 currency code (Error code(s): T52).

The integer part of Amount must contain at least one digit. A decimal comma is mandatory and is included in the maximum length. The number of digits following the comma must not exceed the maximum number allowed for the specified currency (Error code(s): C03,T40,T43).

USAGE RULES

These fields are conveyed for transparency reasons.

The net amount after deduction of the Sender's charges will be quoted as the inter-bank settled amount in field 32A.

This field may be repeated to specify to the Receiver the currency and amount of charges taken by previous banks in the transaction chain. Charges should be indicated in the order in which they have been deducted from the transaction amount, that is, the first occurrence of this field specifies the charges of the first bank in the transaction chain that deducted charges; the last occurrence always gives the Sender's charges.

This field cannot be present when funds transfer is to be executed through the Bank of Russia Payment System, as this information cannot be present in the payment document of the Bank of Russia. Using this field in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT103 understands that in this stage of funds transfer the content of this field will be lost and it's function will not be executed completely.

This field cannot be present when funds transfer is to be executed through the Bank of Russia Payment System, as this information cannot be present in the payment document of the Bank of Russia. Using this field in the payment instructions when transfer is to be executed through the Bank of Russia Payment System, the Sender of MT103 understands that in this stage of funds transfer the content of this field will be lost and it's function will not be executed completely.

The possibility of using of the field should be bilateral agreed between Sender and Receiver.

First subfield - "Date of debit of the Payer's account". Corresponds to the field 71 "Written off from the Payer's account" of the payment document of the Bank of Russia.

Second Subfield - "Received by the Payer's Bank". Corresponds to the field 62 "Received by the Payer's Bank" of the payment document of the Bank of Russia.

Third Subfield - "the mark of the beneficiary's bank" Corresponds to the field 48 "the mark of the bank of the beneficiary" of the payment document of the Bank of Russia.

Fourth Subfield - "Date of filing in the card index". Corresponds to the field 63 "Date of filing in the card index" of the payment document of the Bank of Russia and is used for transmission of the date of recording the payment document into the queue of not-executed in time orders due to lack of funds..

Notes:

1.) The numbers of the fields of payment document of the Bank of Russia are presented according to The Bank of Russia Regulation No.383-P of June 19, 2012, "On the rules of funds transfer execution".

2.) When the format of initial payment document does not contain some of specified fields, or information in them is missing, relevant subfields in SWIFT message are to be filled with digits zero.

3.) If initial payment document does not contain information in any of specified fields, then code word DAS is not used in SWIFT message.

/NZP/ - Continuation of the field 70 "Remittance Information". Total size of payment details in the field 70 and in the field 72 after transliteration must not exceed 210 characters.

/ACC/ Instructions following are for the account with institution.

/INT/ The instructing institution which instructed the Sender to execute the transaction.

/REC/ Instructions following are for the intermediary institution.

/INS/ Instructions following are for the Receiver of the message.

USAGE RULES

Field 72 must never be used for information for which another field is intended.

Each item for which a code exists must start with that code and may be completed with additional information.

Each code used must be between slashes and appear at the beginning of a line. It may be followed by additional narrative text

All codes are indicated between slashes in the beginning of line. Free text with additional information may be indicated after them.

Narrative text relating to a preceding code, which is continued on the next line(s), must start with a double slash '//', and, if used, must begin on a new line. Narrative text should preferably be the last information in this field.

Use of field 72, particularly with uncoded instructions, may cause delay, because, in automated systems, the presence of this field will normally require manual intervention.

It is strongly recommended to use the standard codes proposed above. In any case, where bilateral agreements covering the use of codes in this field are in effect, the code must conform to the structured format of this field.

DEFINITION

This field specifies code(s) for the statutory and/or regulatory information required by the authorities in the country of the Receiver or the Sender/originating customer.

According to SWIFT-RUR Guide, codes for state tax authorities must present in this field when MT 103 includes payment instructions to transfer the tax and other obligatory payments. These codes represent the status of the ordering customer and other details according to the Ministry of the Russian Federation on Taxes and Fees, Ministry of Finance of the Russian Federation and State Customs Committee of the Russian Federation requirements.

Two kinds of obligatory payments can be presented in MT 103:

- transfer tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation

and

- transfer of customs duties or other payments related to external economic activity.

Information following the same code in this field differs depending of the kind of obligatory payment containing in MT 103.

To transfer of tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation this field contains the following information structured by identifiers in slashes “/”.

IDENTIFIERS

In formatting of SWIFT message to transfer of tax, fee and other duties administrated by tax authorities to the budget of the Russian Federation this field should being split to subfields. Each subfield has an identifier and strictly corresponds with the field of the payment document of the Bank of Russia.

Note: in case of absence of particular values user should act in accordance with Ministry of Finance of RF and the Bank of Russia regulations to use number of zeroes needed.

Each subfield contains code sequence. The following subfield identifiers and code sequences are to be used:

CATEGORY 2. TRANSFERS OF FINANCIAL INSTITUTIONS

Messages of Category 2 exchanged between and on behalf of financial institutions.

This chapter contains description of MT 202 - "General Financial Institution Transfer" financial institution transfers, which are orders for the movement of funds, originated by a financial institution,

- in favour of itself

or

- another financial institution.

The messages contains payment instructions, where all parties involved are financial organizations.

SWIFT-RUR Guide doesn't allow use of MT 200 "Financial Institution Transfer for its Own Account" because the Bank of Russia regulations require mandatory definition of beneficiary account number.

2.3 MT 202 GENERAL FINANCIAL INSTITUTION TRANSFER

2.3.1 MT 202 Scope

This message is sent by or on behalf of the ordering institution directly, or through correspondent(s), to the financial institution of the beneficiary institution.

It is used to order the movement of funds to the beneficiary institution.

This message may also be sent to a financial institution servicing multiple accounts for the Sender to transfer funds between these accounts. In addition it can be sent to a financial institution to debit an account of the Sender serviced by the Receiver and to credit an account, owned by the Sender at an institution specified in field 57a.

To execute the payment through the Bank of Russia Payment System MT 202 could be transformed into Payment order (form 0401060) or Bank order (form 0401070). Bank order is limited in usage by funds transfers through urgent transfer service in favour of the foreign banks which information exists in the Bank of Russia BIK Directory and by the Bank of Russia funds transfers in favour of banks and their branches initiated by orders of the abovementioned foreign banks received in accordance with account managing contract terms and conditions. During settlements with CLS Bank International requirements to the information definition in fields 52a, 56a, 57a, 58a of MT 202 are defined by terms and conditions of correspondent account managing.

Based on clarifications of the Bank of Russia, symbols of braces, which limit coded information of the currency transaction in the field "Details of payment" of the Payment Order, must be replaced by round brackets via the process of transliteration from Cyrillic alphabet to Roman alphabet in relevant field of SWIFT message. In case of reverse transliteration, round brackets are replaced by symbols of braces.

So, the last appearance of the code word CHGS always specifies the charges (if any) of the account servicing institution.

The Ordering Customer is described in this field after the code word ORDP. Information, following this code, is a copy of the field 50a of Customer Transfer (SWIFT MT103) or a copy of the field 52a of Financial Institution Transfer (SWIFT MT 202) or the name of the Ordering Customer and its details from the payment document of the Bank of Russia in full or partially. Code word ORDP always appears in the start of the line.

For debit entries, the Beneficiary may be described with the code word BENM. Information, following this code, is a copy of the field 59a of Customer Transfer (SWIFT MT103) or a copy of the field 58a of Financial Institution Transfer (SWIFT MT 202) or the name of the Beneficiary Customer and its details from the payment document of the Bank of Russia in full or partially. Code word BENM always appears in the start of the line.

Payment details from the field 70 "Remittance Information" of SWIFT message or from the field "Details of Payment" of the payment document of the Bank of Russia may be presented following code word NZP.

Used in accordance with the Bank of Russia requirements in this field it could be defined UIP from fields 72, 23E of payment instructions or "Code" from payment document of the Bank of Russia preceded with code word UIP.

In case remittance information from field 70 of the payment instruction is to be included in this field, it should be preceded by the code /REMI/.

Charges which are clearly indicated in another message concerning the same entry, or which form an integral part of another message, for example, proceeds of a collection, do not need to be specifically indicated in the statement.

Deductions, for example, charges, above and beyond those previously accounted for in a related message shall appear separately with the appropriate code. They shall use the same reference for the account owner or other suitable reference if no reference for the account owner is available.

The account servicing institution must not 'bulk' separate transactions, charges, or charges with transactions. When booking multiple messages, individual transactions, for example, one entry per TRN (field 20), must be booked.

It is recommended that statements be sent daily, that is, at the end of each business day, when movement in the account has occurred. If no movement has occurred, that is, no entries have been posted, it is recommended that the statement frequency should be monthly, and that the maximum interval between statements should not exceed one year.

If necessary and under bilateral agreement Account servicing institution send interim statement to Account owner (information related to operations executed at particular time of operational date).

To facilitate manual reconciliation, it is recommended that statement entries be sorted by debits and credits and these by value date in ascending amounts.

Since the length of a SWIFT message is restricted to the maximum input message length, several messages may be required to accommodate all the information for one statement.

NETWORK VALIDATED RULES

Subfield 1, Value Date, must be a valid date expressed as YYMMDD (Error code(s): T50).

The SWIFT System validates subfield 2, Entry Date (Date in reduced ISO form MMDD), using current System Year (Error code(s): T50).

The integer part of Amount must contain at least one digit. The decimal comma ',' is mandatory and is included in the maximum length (Error code(s): T40,T43).

When the first character of subfield 6, Transaction Type Identification Code, is an 'S', the remaining characters must be in the range 100-999 (Error code(s): T18).

USAGE RULES

This field may be repeated within the constraints of the maximum input message length.

'Original' advice for charges, that is, the first time the account owner is informed of a charge, must be identified in subfield 6, Transaction Type Identification Code, with the transaction type code 'FCHG'.

The following rules apply to subfield 7, Reference for the Account Owner:

At least one valid character other than a blank must be present.

For debit entries, the purpose of this subfield is to identify, to the account owner, the instruction which caused the debit. Therefore, the content of this subfield is the field 20 Sender's Transaction Reference Number (or its equivalent) of the original instruction. The same reference is specified in field 21 of MT 900 related to this transaction.

Credit entries may be the result of one of the following situations:

1. The account servicing institution is identifying, to the account owner the receipt of funds for its account as a result of a related transaction. In this case, the content of subfield 7, Reference for the Account Owner is the reference for the beneficiary (for example, field 21 Related Reference) of the related transaction. The same reference is specified in field 21 of MT 910 related to this transaction.

2. The account servicing institution has issued a payment instruction to the account owner and the credit identified in this subfield is for that payment. The content of subfield 7, Reference for the Account Owner is the field 20 Transaction Reference Number (or its equivalent) of the payment instruction issued by the account servicing institution.

If no reference is available for subfield 7, Reference for the Account Owner, the code NONREF shall be used. The account servicing institution must then supply, in subfield 9, Supplementary Details, what it considers to be the best alternative information.

This reference must be quoted in all cases when available. In cases where a transaction passes through several financial institutions, the original reference must always be forwarded.

This reference must always be quoted against any charges or fees debited by the account servicing institution.

Debits against standing instructions must show the reference of the standing instruction.

In cases where a mutually agreed alternative reference exists (for example, in foreign exchange or money market transactions), this reference should then be used.

If the statement entry concerns a cheque, the cheque number should be indicated in this subfield.

The following rules apply to subfield 8, Account Servicing Institution's Reference:

The content of this subfield is the account servicing institution's own reference for the transaction.

When the transaction has been initiated by the account servicing institution, this reference may be identical to subfield 7, Reference for the Account Owner. If this is the case, Account Servicing Institution's Reference, subfield 8 may be omitted.

The following rules apply to subfield 9, Supplementary Details:

When no reference for the account owner is available, that is, subfield 7, Reference for the Account Owner contains NONREF, the account servicing institution should provide the best available alternative information in this subfield.

As mutually agreed, the credit entry based on the payment document of the Bank of Russia may contain the number of this document in Subfield 7, and in Subfield 9 - information, to allow the account owner to identify the transaction, for example, account number of the Ordering Customer with Ordering Institution and BIK of the Payer's Bank.

Additional information may be presented when credit or debit advice was not sent under this transaction or when additional details facilitate reconciliation of the account.

Attention! Structure of information in the Subfield 9 "Supplementary details" is defined by account servicing institution and should be clarified to the Receiver.

Field 62 is used in the last or the only message of the abstract with option F; final outgoing balance is indicated in it. If abstract is presented by more than one message, then in all message except the last one, this field is used with option M and contains intermediate outgoing balance.

Contents of the field 62F "Final outgoing balance" is transferred to the field 60F "Initial incoming balance" of the next abstract of the client's account. Contents of the field 62M "Intermediate outgoing balance" is transferred to the field 60M "Intermediate incoming balance" of the next message of the same abstract of the client's account.

All Common Group Messages may be used under SWIFT-RUR Guide without any limitations. The main and the only requirement for messages of this group is correct use of the transliteration rules.

ADDENDUMS

Addendum 1. Use of SWIFT-RUR Guide according to EU regulations.

When payment chain includes financial institutions in countries- members of the European Union, EU regulations mentioned below must be applied to for funds transfers in Russian currency as well as requirements stated in SWIFT-RUR Guide:

1. Payment instructions should include complete information about as following:
 - name, address and debiting account number of Payer; or
 - name, the date and place of and debiting account number of Payer; or
 - name, customer identification number or national identity number and debiting account number of Payer; or
 - if the transfer executes without opening account then should be specified an unique identifier for fund returning purposes.
2. IBAN should be used for transfer of funds in favor of EU banks customers.
3. Fields 86 and subfields 9 of fields 61 in MT 940 and 942 may contain ERI to transport dual currencies, as explained in the chapter "Euro-Related Information (ERI)" in the Standards MT General Information.

If conversion transaction applied to the account (payment in currency different than currency of the account) the code word EXCH is placed between slashes, followed by the exchange rate, format 12d, and terminated with another slash. The code may be repeated if the account servicing institution wants to report an exchange rate that it applied, in addition to the exchange rate received in the instruction. The order in which the exchange rates are specified is the same as the order in which the rates have been applied during the transaction. So, the last appearance of the code word EXCH always specifies the rate applied by the account servicing institution.

STP rules of correspondent bank should be used as well.

1. Such transliteration table is used by banks in practice for information exchange by means of facilities those do not support lowercase letters (e.g. telex) and is regulated by bilateral correspondent agreements.

2. The rules described in 1.3 item are used except following:

2.1. Instead «+» in first position of field 20 as transliteration sign is used apostrophe;

2.2. In case of need to transfer Latin words inside Cyrillic instead apostrophe is used YX combination as «RUS/ENG–ENG/RUS» trigger. If Latin part of information inside Cyrillic includes YX combination then the Sender repeat it twice and the Receiver translate YXYX to original single YX combination.
